Greetings Boaters,

Safe Boating Course Offered

An Environmental Police and NASBLA certified one day safe boating course will be offered in Manchester this August. Classes will be held at Manchester Town Hall on August 19th with an exam on the same day. Class start time will be 8:00AM .Safe boating certificates will be issued to all students with a passing grade. There is no fee for this course.

Please contact the Manchester Harbormaster at (978) 526-7832 and leave a message with a return phone number to receive a sign up form for this important course. Class size is limited to 20.

Rules and Regulation Changes

Please find attached to this e-mail a marked up copy of the Manchester Waterway Rules and Regulations. All changes are marked in red. Changes will go into effect on September 1st. Please contact the harbormaster if you have any questions.
Some changes of note;

- Outboard motors and outdrive lower units may not be left in an “up” position unless the skeg and propeller are covered so as to prevent damage to nearby vessels. Small outboards suspended from a vessels rail and protruding beyond the topsides of the vessel are included in this regulation. Vessel owners not in compliance will be responsible for damage caused by an uncovered unit left in the “up” position. This applies to vessels on moorings, town docks or any location where damage to a nearby vessel could occur.

- All children twelve and under are required to wear a USCG approved life jacket of an appropriate size while on a public float. Access to public floats will be denied for failing to observe this regulation.
- Late Fee for Slip Renewals after June 1st: \$100
- Late Fee for Mooring Renewals after March 31st in the following mooring fields: Magnolia, Black Beach and Long Beach: \$100
- Failure to display current Waterway Permit sticker: \$100

Stickers

Be sure your Waterway Sticker is on your boat. Any vessel not displaying a 2013 sticker will pay an extra fee at renewal in 2014. Sticker inventory starts this week.

Marine Mammals

A **beached whale, dolphin or porpoise** should be reported immediately and left alone pending further instruction. **Call the New England Aquarium's 24-hour Marine Animal Hotline: (617) 973-5247.** Please try to remain calm and leave your name and a phone number where you can be reached.

Sea turtles in our region do not typically come ashore unless they are seriously debilitated. **Call the New England Aquarium's 24-hour Marine Animal Hotline: (617) 973-5247.** Please try to remain calm and leave your name and a phone number where you can be reached.

Seals belong on the beach. It's normal. Please don't disturb them. Unlike whales or dolphins, seals are semi-aquatic and are comfortable out of the water. Most seals come onto beaches to sleep, nurse or soak up some sun.

What should you do if you spot a seal on the beach?

Seals are cute, but they are wild animals and should not be disturbed. By getting too close, you could upset the seal or possibly get bitten.

- **Watch quietly** from at least 150 feet away.
- **Keep dogs away** from the seal.
- **Do not** offer the seal food or water.
- **Do not** pour water on the seal or try to cover it with a towel or blanket.
- **Do not** try to make the seal move.
- **Does the seal look injured or unhealthy?**

Most seals on the beach are perfectly healthy, but sometimes they do need human assistance. Does the seal have any **obvious injuries, gunky eyes, or look skinny or underweight**? If the seal does, please take notes on its location, size, coloring and behavior and call the New England Aquarium's Marine Animal Hotline at **(617) 973-5247**.

All marine mammals are protected by the Marine Mammal Protection Act. This law makes it illegal to touch, disturb, feed or otherwise harass marine mammals without authorization.
